


## Access to the platform

The user accesses the platform for the Young Researchers 2024 Notice by means of a login on the site. The online application window can be accessed by means of a SPID, CIE or CNS digital identity.

If the user does not have a SPID digital identity, a CNS smart card or a CIE, he or she will necessarily have to apply for one from one of the appointed operators or bodies.



European/extra-European citizens who do not have a digital identity will have to enter their credentials by clicking on **“Sign in”** and entering their e-mail and password in the respective fields in order to access the application's home page.

If this information is missing, the user (European/extra-European citizen) must register by clicking on the **“Singup”** button.

Registration involves filling in a form consisting of the following fields:

Once the form has been completed and consent to the privacy policy has been given, the user clicks on **“Confirm”** through which he can submit his registration to the system.

After clicking on the **“Confirm”** button, the user displays the following confirmation message.


### Account activation

At this point, the user logs in to the application of the call of interest and enters his credentials, e-mail address and provisional password, the latter to be changed the first time he logs in.




Form fields and buttons visible in the screenshot:

Activation must take place within 48 hours of receipt of the e-mail, otherwise the account will be cancelled on stand-by.

If the user has clicked on the **"Forgot your password"** link on the login page as follows:

You will be redirected to a Reset Password page, where you must enter the e-mail address on which you will receive your new password.

By clicking on the **"Confirm"** button, the user displays the following message on the screen:

The system sends an e-mail to the address provided by the user with the provisional password upon confirmation.

At this point, the user must log in to the application at the URL of the call for interest as a European/extra-European citizen and enter their credentials, e-mail address and temporary password (to be changed on first access).

**Note1:** In order to be able to fill in the application with optimal platform performance, it is advisable to use the Google Chrome browser.

**Note2:** If you decide to use CNS access, you may encounter login problems due to the characteristics of the authentication device used. It is therefore advisable to attempt the login operation via incognito mode. In case of further problems, please contact your device vendor to check if updated drivers are available.
