- that they do not find themselves in any situation of incompatibility or conflict of interest with the position for which they are submitting the application, in compliance with the provisions of Art. 3, paragraph 3 of the call, with the other provisions of the law or disciplines of the sector;
- to have proven experience in leading research teams on large-scale international projects in the above-mentioned fields;
- to have at least 5 (five) years of proven experience in the use and/or management of high-tech research infrastructures;

- to have obtained funding on a competitive basis for research in international contexts.
